PLANT BREEDER'S RIGHT ACT NO. 15 OF 1976 section 23, Rights of holder of Plant Breeder's Rights: The effect of the protection given under this Act by the grant of a plant breeder's right (PBR) shall be that prior authority shall during the currency of the PBR be obtained by way of licence under section 25 or 27 by any person intending to undertake the following:
  - a) Production or reproduction of material (multiplication);
  - b) Conditioning for the purpose of propagation;
  - c) Sale or any other form of marketing;
  - d) Exporting;
  - e) Importing;
  - f) Stocking for any of the purposes referred to in paragraphs (a) to (e) of
    - I. Propagation of the relevant variety; or
    - II. Harvested material, including plants, which was obtained through the unauthorised use of propagating material of the relevant variety.
